

# Markets in Crypto Assets Regulation (MiCA)

- Approved by the European Council on October 5, 2022
- It will come into force in the middle to the end of 2024
- A harmonized framework will established governing the crypto industry in the European Union.

# **EU** Anti-Money Laundering Regulation

- Will cover CASP as defined by MiCA
- Special requirements will needed for a crypto industry where blockchain analytics and crypto screening tools will be an essential part of the AML regime of each licensed CASP.

#### MiCA pursues four main goals: Provide legal certainty Replace the existing concerning crypto assets national framework not subject to existing EU Establish uniform applicable to crypto legislation on financial rules for crypto assets with EU Establish specific rules markets supranational legislation service providers for the handling of and resolve these on financial markets stablecoins, including in issues at the EU level cases when offered as a form of electronic money
